

MODEL PRIVACY NOTICE

When to use this model:

The provisions of Governor Locke's Executive Order 00-03 requires each executive state agency that operates an Internet web site to adopt this Model Notice modified only to the extent necessary to address practical and legal considerations specific to the implementing agency. A link to your Privacy Notice developed from this model must be prominently placed on the agency's home page and on any other page where personal information is collected.

Instructions for using the model:

Required sections. This model contains different sections that will be assembled to compose each agency's web site Privacy Notice. The sections are identified as either required for all privacy notices, or required only under certain circumstances. Agencies should ensure that the text in every section is consistent with its practices and modify as necessary.

Customization. Various words and phrases of this model are set aside in brackets ("[]"). These brackets indicate a need to either (a) customize the bracketed content to address the agency's needs, or (b) determine whether inclusion of the bracketed content is or is not appropriate for the agency.

Notes and instructions in *italics*. Where appropriate in the body of this Model Notice, notes and instructions are provided close to the content to which they relate. These are printed in *italic* font and should be removed before the notice is posted.

Modification of model. This model may not accommodate all agencies' needs and circumstances. It is permissible to modify any provisions of this model to the extent necessary to accommodate the individual needs and circumstances of each agency.

Future review of agency notice. It is recommended that agencies periodically review the Privacy Notices to ensure their accuracy. Appropriate changes should be made as agencies' web site and business practices change.

Section B. Information Collected and How it is Used *(Required section. Use this section to describe the information your agency collects automatically from visitors and also the information that is requested from visitors. Information collected if you only browse this site.

If you do nothing during your visit to our web site but browse, read pages, or download information, we will gather and store certain information about your visit. This information does not identify you personally. We automatically collect and store the following information about your visit:

1. The Internet Protocol Address and domain name used. The Internet Protocol address is a numerical identifier assigned either to your Internet service provider or directly to your computer. We use the Internet Protocol Address to direct Internet traffic to you. This address can be translated to determine the domain name of your service provider (e.g. xcompany.com or yourschool.edu);
2. The type of browser and operating system you used;
3. The date and time you visited this site;
4. The web pages or services you accessed at this site; and
5. The web site you visited prior to coming to this web site.

The information we automatically collect or store is [logged and] used by [agency] only to improve the content of our web services and to help us understand how people are using our services. We use your email to respond appropriately. This may be to respond to you, to address issues you may identify, to further improve our web site, or to forward the email to another agency for appropriate action. We collect no personal information about you unless you voluntarily provide it to us by sending us email, participating in a survey, or completing an on-line form. To the extent required to prevent an unreasonable invasion of personal privacy interests protected by RCW 42.17.310 and 42.17.315, an agency shall delete identifying details in a manner consistent with RCW 42.17.310 and 42.17.315 when it makes available or publishes any public record; however, in each case, the justification for the deletion shall be explained fully in writing.

In the event of a conflict between this Privacy Notice and the Public Records Act or other law governing the agency's disclosure of records, the Public Records Act or other applicable law will control.

Section E.
